












Background

Since January 2024, **19 Thematic Projects** from the **Interreg EURO-MED programme**, working under the **"Green Living Areas" mission**, have started their journey to **improve the sustainability of the territories** and consequently, the quality of life in the EURO-MED region, **supporting local and regional authorities and main stakeholders in this transition**. The Thematic Projects will not be alone in facing this challenge and will be accompanied by **one Mission task force** composed by **2 governance projects**, supporting them in different dimensions:

- The Community4Living Areas project C4LA, on the one hand, will build a strong community among the projects of the mission, facilitating the creation of synergies among their activities and results. The C4LA project will be a booster of the Thematic projects' results and impact, allowing also to obtain cross-fertilisation with other EU programmes working in the same direction and on the same themes. Moreover, the C4LA project will give a common direction to the 19 Thematic Projects, allowing the results to flow together towards the same main goal.
- 2. The **Dialogue4LivingAreas project D4LA**, on the other hand, will **amplify the transfer of policies** by fostering **dialogue among policymakers and public stakeholders**, focusing on **continuous policy improvement and transformation**.

The Green Living Areas Thematic Community Kick-off event, organised by the C4LA project, with the collaboration of the D4LA project, has the objective of creating the Green Living Areas – GLA Community by making the partners of the various projects aware of each other's activities to build all type of synergies, from technical to policy exchange, among them. This first meeting among all the members of the Community represents the first of several steps that community members will take together during their project and even the current programming period.

The kick-off event is organised across **2 days**.

Day 1: The first day will be entirely dedicated to **community building**, with mutual presentations, a cocreation workshop, and community building dedicated activities.

Participants invited: Lead partners, partners in charge of communication, and synergies with the governance projects.

Day 2: The day will be **open to actors from outside the Community**, notably public policymakers, to exchange best practices related to tools, strategies, and policy instruments for **promoting greener territories and engaging citizens in the transition**. It is a first cross-fertilization and amplification of the Community resonance and the occasion of **the launch of the Institutional Dialogue Process**. *Participants invited:* Authorities in charge of public policies from and outside the Green Living Areas Thematic Community.

We welcome all participants to the Green Living Areas Thematic Community. We are thrilled to embark on this rewarding journey in the Euro-MED ecological transition!
